ARTICLE OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS:-

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating, under the laws of the State of Montana, and particularly under sections 4224 to 4229 inclusive, revised laws of 1907 of said State of Montana, and in pursuance of the purpose for which we have been elected as hereinafter set forth, a religious organization to be known as First Church of Christ, Scientist, Bozeman, Montana, and we hereby certify:

First:- That the name of this corporation is and shall be:
First Church of Christ, Scientist, Bozeman, Montana.

Second:- The purpose for which it is formed is to establish a church organization known as above, and for the purpose of maintaining and spreading the doctrine of Christian Science, as contained in the text book, Science and Health, with Key to the Scripture, by Mary Baker Eddy; and in connection therewith to establish and maintain suitable and customary organizations for the purpose of public worship and religious training in accordance with the above, and to have and to hold such necessary real estate and improvements, and to hold and administer trust funds for general and special purposes, and for holding the legal title to real estate for the use of and in trust for the said church, as may be acquired either by purchase or by gift, or otherwise, and to have general charge of the business affairs of said church.

Third:- That the place where its principal business is to be transacted shall be in the City of Bozeman, County of Gallatin, State of Montana.

Fourth:- That the number of its trustees who shall have the management of its affairs shall be seven (7) and the names and residences of those who have been elected for the purposes of managing the affairs of the said corporation for the first three months, or until their successors are elected and qualified, are: Fred Jacobs, J.A. Bartholomew, Geo. Gibson, Clyde Corbly, Mrs. Laura Corbly, R.R. Finlay and W.H. Randall, all of whom reside in the city of Bozeman, County of Gallatin, State of Montana; that all of said trustees were duly elected at a meeting of

the members of said organization, duly held, in the rooms under the Gallatin State Bank, in the city of Bozeman, Montana, on the 12th day of September, 1910, for the purpose of organizing said corporation, the records of which meeting are more fully given in the exhibit forming a part of these articles and known as "Exhibit A", to which reference is hereby made as a part hereof.



EXHIBIT A.

Special meeting, in rooms under Gallatin State Bank,
Bozeman, Montana, September 12th 1910.

The meeting was called to order by the Chairman. Minutes of last meeting were read and approved as read.

Chairman stated the object of the meeting, saying it was called to vote upon the following resolution:

"Resolved, That the trustees of this church, to-wit: Fred Jacobs, J.A. Bartholomew, Geo. Gibson, Clyde Corbly, Mrs. Laura Corbly, R.R. Finlay and W.H. Randall, be and they are hereby authorized to incorporate this church as First Church of Christ, Scientist, Bozeman, Montana, and for that purpose to file with the proper officers Articles of Incorporation as required by law." The resolution was voted on and adopted by a unanimous vote of the members present. Adjourned.
