

ARTICLES OF INCORPORATION OF THE CHRISTIAN REFORMED CHURCH OF CONRAD

KNOW ALL MEN, That we, the undersigned have this day voluntarily associate ourselves together for the purpose of incorporating under the laws of the State of Montana, and for the purpose for which we have been elected as herein after set forth, a religious corporation to be known as the "CHRISTIAN REFORMED CHURCH OF CONRAD."

And we certify that the objects for which this corporation is formed are: prosecuting and defending suits at law, taking and holding by purchase, gift, devise or bequest personal and real estate, and to use and dispose thereof for the purpose of building and maintaining a church, parsonage, schools, hospital and cemetery at or near the town of Conrad, in Teton County, State of Montana.

To take charge of such buildings, estate and property, and the affairs thereof; That the principal place of business of this corporation shall be in the Town of Conrad, Teton County, State of Montana.

That the term of the Incorporation shall be continual; That the number of trustees who shall have the management of its affairs as aforesaid shall be four, and the names of the trustees elected for the first year are: PETER DeBOER, H. BOERMAN, PETER EELKEMA, and J. V. KROEZA.

That the said trustees were duly elected at a meeting of the said church duly convened and held at Kemper School house for the purpose among other things to take charge and management of its property and affairs, and to form this incorporation.

That a majority of said members were then and there present, and voted at such election, for the above named trustees as is more particularly set forth in the certificate and verification by the officers who conducted the election, hereto annexed and made part of these articles.
