

ARTICLES OF INCORPORATION

This corporation, organized under and virtue of the laws of the State of Montana, is for the purpose of mutual insurance by its members against loss or damage by fire or lightning.

Article I.

Name and Territory. The name of this organization shall be: "Farmers Mutual Fire and Lightning Insurance Company of Custer and Dawson Counties", to embrace in its territory the counties of Custer and Dawson, in the state of Montana.

Article II

Object. The object of the company is to mutually insure the property of its members against loss or damage by fire or lightning in such manner as shall be set forth in the by-laws.

Article III

Principal Business Plee. The place of holding the annual meetings of the company and the transacting of its principal business shall be at the school house located on section 20, township 12 east, and range 61 north, Custer County, Montana.

Article IV

Duration. This company shall continue for a period of twenty years from date of these articles of incorporation, but may be dissolved by a majority vote of its members.

Article V.

Officers. The officers of this company shall be: President, Vice-President, Secretary, treasurer and nine directors, to be elected as provided in the by-laws, Names of those who have been regularly appointed to take charge of the affairs of the company until its first annual meeting are: J. L. Jordan, Chairman, Paul S. Hede, Charles I Cook, A. Barc^{lay} and Herman Schmudlack.
