

ARTICLES OF INCORPORATION
OF THE
MASONIC TEMPLE ASSOCIATION OF MILES CITY, MONTANA.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Montana, and that we hereby certify:

FIRST. That the name of the said corporation is MASONIC TEMPLE ASSOCIATION OF MILES CITY, MONTANA;

SECOND: That the purpose for which it is formed is to build, operate and maintain a Masonic Temple within the City of Miles City, Montana, for the use and benefit of the Masonic Fraternity of said City of Miles City, Montana, and any allied or associated organizations; to purchase, take, lease hire or otherwise acquire any real or personal property suitable for the purposes for said Masonic Fraternity, and to lease or rent any portion or portions of any building or buildings erected by such corporation to any person or persons, natural or artificial, society or societies, whatsoever; to borrow money or securities, and to secure any loans made to such corporation by bonds or bonds, mortgage or mortgages, upon any property of said corporation, either real or personal; to sell, transfer assigns or in any manner convey any of the property of said corporation; to purchase, acquire, hold and dispose of stocks bonds or other evidences of indebtedness of any corporation, domestic or foreign, and to issue in connection with such purchase or acquisition the stocks, bonds or obligations of this

corporation, and while owner thereof to protect and exercise in respect thereto all of the rights, powers and privileges of individual owners or holders of such stocks, bonds or other evidences of indebtedness;

THIRD: That the place where its principal business is to be transacted shall be at the city of Miles City, in the County of Custer and State of Montana;

FOURTH: That the term for which it is to exist is twenty years from the date of incorporation;

FIFTH: That the number of its directors shall be five and the names and residences of those who are appointed for the first three months and until their successors are elected and qualify are:

SIXTH: That the amount of the capital stock of this corporation shall be Fifty thousand (\$50,000.00) Dollars, divided, into one thousand shares of the par value of Fifty (\$50.00) Dollars each;
