Kartack, all residing in the County of Teton, in the State of Montana have this day voluntarily associated themselves together for the purpose of incorporating under the laws of the State of Montana, and in pursuance of the purposes for which trustees have been elected, as hereinafter set forth, a corporation to be known as

THE CROWN HILL CEMETARY ASSOCIATION

And we, the undersigned, certify that the objects for which this corporation is formed are: To establish a cemetery or burial place for the dead in the County of Teton, in the State of Montana, in accordance with the Laws of the State of Montana, and the by-laws that may be hereinafter enacted by said corporation.
