signed, being respectively the chairmand and secretary of a
meeting, held at Young's Office, at Redstone, in Sheridan
County, Montana, on the 5th day of August, 1913, at
~~five~~ o'clock P. M., being the time and place agreed upon
by the majority of the associates hereinafter named, hereby
certify as follows:

1. That the names of the associates who attended such
meeting are as follows: G. W. Minor, Wm. Hodgeman, L. P.
Kurtz, W. K. Young, F. C. Schroeder, Ray Proffilt, L. C.
Lindemann, R. Reed and Frank Gordon

2. The corporate name of the association determined upon
by the majority of said persons who met at the time and place
hereinbefore stated, is as follows: "THE REDSTONE CEMETARY
ASSOCIATION" of Redstone, Sheridan County, Montana.

3. The number of persons fixed upon to manage the
concerns of the Association are nine.

4. The names of the trustees chosen at said meeting
and their classification are as follows:

Those in the first class who hold their office
for one year: G. W. Minor, Carl Bull
and W. K. Young;

Those in the second class to hold their office
for two years: Ralf Reed, L. P. Kurtz
and Walter Snyder.

Those in the third class to hold their office
for three years: H. D. Loucks, J. D. Matkin
and M. S. Knight.

The day of the year fixed upon for the annual election of trustees is the first Monday of August of each year.

6. The trustees of said association shall be elected at said annual meeting by a ballot, and each person owning a lot in said cemetery at the time of the holding of said annual meetings shall be entitled to cast one vote for each trustee to be elected at said meeting.
