About Pre-Registration

Online Pre-registration was developed to make the voter registration process more efficient and more accurate.

- Because full online voter registration is not yet implemented, applicants who pre-register online must still appear in your offices to sign the pre-filled registration form that you will print.

There are two major parts of Pre-Registration:

1. What the public sees ([The Web Page](#)).
2. What the election official sees ([MT Votes](#)).

Once a pre-registration has been entered, you will be notified in MT Votes with a red link to the **Online Pre-Registration**.

If the applicant chose the incorrect county when completing the online process, you can select the right county and click **Change Voter's County**.

If you select a duplicate, it will bring over the original record (a).

The information entered into the pre-registration site will populate on the right hand side (b.). If you don't want to over-write something in the original record, uncheck that box from the pre-registration information on the right-hand side.
