

You have one step left in order to attain your *elective* North Carolina Certificate of Existence. You will also receive a package containing corporate agreement templates for your business that can be used in a variety of situations for your company. Below is a form for your newly registered business and please confirm the accuracy of the information for your North Carolina Certificate of Existence request with corporate template agreements.

A North Carolina Certificate of Existence attests to the legal status of business entities such as corporations and limited liability companies operating in North Carolina, and serves as a legal document. A North Carolina Certificate of Existence may be required for loans, to renew business licenses, or for tax and other business purposes. It certifies that your North Carolina business is in existence, is authorized to transact business in the state and complies with all relevant state requirements.

Banks will often require a Certificate of Existence from a business both when opening bank accounts as well as when obtaining financing and the Certificate of Existence is also often required when doing business with other states. The Certificate of Existence bears the official seal of the North Carolina Secretary of State.
